

## WAIVER OF LIABILITY

Due to the outbreak of the novel Coronavirus (COVID-19), AMB Driving School is doing everything we can to protect you, our clients, our contractors, our community and our staff. To this extent, AMB Driving School will be following recommendations of the Government of Ontario, and Professional Regulation guidance with regard to social distancing practices and sanitation. We ask that our students/clients disclose their health history and continue to implement these sanitation and disinfection procedures.

**Symptoms of COVID-19 may include, but are not limited to fever, fatigue, dry cough and difficulty breathing.**

I, \_\_\_\_\_ (Student/Guardian), agree to the following:

- I, nor members of my household, have not experienced any of the symptoms listed above within the last 14 days.
- I, nor members of my household, have not travelled internationally in the last 14 days.
- I, nor members of my household, have not traveled to a highly impacted area within Canada in the last 14 days.
- I, nor members of my household, do not believe that we have been exposed to someone with a suspected and/or confirmed case of the Coronavirus (COVID-19).
- I, nor members of my household, have not been diagnosed with the Coronavirus (COVID-19) within the last 14 days.
- AMB Driving School cannot be held liable from any exposure to the Coronavirus (COVID-19) caused by misinformation on this form or the health history provided by each client.
- If I take any steps to make a claim for damages against AMB Driving School, its agents, contractors, employees or any other released parties, I shall be obligated to pay all legal fees and costs incurred as a result of such claim.

**AMB Driving School is following these enhanced procedures to prevent the spread of the Coronavirus (COVID-19)**

- All students must bring their own face covering and must wear face covering for the entire duration of the service or service will be denied.
- A maximum of 1 student will be allowed in the automobile
- We discourage guests accompanying scheduled students.
- Additional time will be scheduled in between client appointments to limit client contact.
- Each client is required to use hand sanitizers on their hands upon arrival and before departure.
- All surfaces will be thoroughly cleaned with hospital grade disinfectant before and after each student, according to the manufacturer's directions.

I further acknowledge that if I or any members of my family experience any symptoms associated with COVID-19 within 14 days of any scheduled interactions with AMB Driving School employees, contractors, and program participants, then I shall forthwith inform AMB Driving School of same.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I, or my child(ren), may be exposed to or infected by COVID-19 by receiving services from AMB Driving School and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at AMB Driving School may result from the actions, omissions, or negligence of myself and others, including, but not limited to, AMB Driving School employees, contractors, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at AMB Driving School or participation in programs ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless AMB Driving School, its employees, agents, contractors, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of AMB Driving School, its employees, contractors, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any services rendered.

I take the full responsibility of providing my health condition at least 24 hours before the appointment with AMB Driving School to my assigned instructor and/or AMB Driving School. If I failed to provide any health conditions at least 24 hours before the appointment then I will be held responsible to pay a lesson cancellation fee of at least \$60.00 and all other financial cost incurred to my assigned instructor and/or AMB Driving School. I also acknowledge that all appointments can be rescheduled per the discretion of AMB Driving School.
